# Contract and Terms of Business

1. **Date Holding Deposit** - A 30% deposit is payable when the client signs this contract to secure and hold their wedding date. The deposit is deducted from the total price. The balance of payments is to be made at least 21 days prior to the wedding.

2. **Cancellation** - The client may cancel this contract at any time by giving written Notice to AS Photography, but in doing so shall forfeit any monies paid. Should cancellation be received less than 8 weeks prior to the date of the wedding the client shall pay the contract value.

3. **Copyright** - The copyright in all photographs created by AS Photography shall remain the property of AS Photography in accordance with the Australian Copyright Act 1968.

4. **Display** - AS Photography reserve the right to use any photograph for display, advertising, exhibition or competition.

5. **Digital files** - Digital Files remain the property of AS Photography.

6. **Sole Rights** - AS Photography shall be the sole PROFESSIONAL Photographer at the wedding.

7. **Coverage start time** - Photographer shall stay for 6,8 or 10 hours based on package selected and start time agreed to by client and photographer.

8. **Shooting Style** - Client acknowledges that they are familiar with the photographer's portfolio and is requesting services with knowledge of the photographic style. The photographers work is constantly evolving; the photographers services are of a unique and artistic nature; That the photos may be different from those taken in the past and in creating the photos the photographer shall use his artistic judgement to create images consistent with his personal vision of the event.

9. **Liability** - AS Photography shall carry out this assignment with due and professional diligence. Elements beyond the studio's control including faulty material, equipment failure, damaged or corrupt memory cards, the loss of digital files in transit to professional laboratories employed by the studio, industrial disputes, civil disturbances, or weather conditions which may inhibit which or prevent the studio completing in whole or part this assignment. In this case the studio shall not be liable for its complete performance of the assignment.

It is agreed that the liability of the studio shall be limited to a refund of any money paid under this agreement which shall be in full and final satisfaction of any damage or loss suffered.

10. **Additional Costs** - The booking of and any additional costs incurred for photography locations and parking fees are our responsibility and may be deducted from the photographic coverage unless paid for separately. **(If the photographer is required to remain after the meal, a meal should be provided)**

11. **Albums** - One round of album image changes can be made. Changes must take place within 4 weeks of receiving album proof. Album will go to print after 4 weeks of receiving the album proof if no correspondence is made. Each additional round of changes after the first included are \$150 per round.

11a. If no correspondence is made to finalise wedding album within 12 months of wedding album will be forfeited.

12. **Delivery** - Delivery of photos and slideshow will take between 4 to 6 weeks after wedding date.

14. This agreement contains the entire understanding between ANDREW SZOPORY PHOTOGRAPHY and the CLIENT. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing signed by all parties. In the event that any part of this agreement is found to be invalid or unenforceable the remainder of this agreement shall remain valid and enforceable. Any agreement to waive one or more provisions of this agreement or any failure by one or both parties to enforce a provision of this agreement shall not constitute a waiver of any other portion or provision of this agreement.

15. **Postponement** – Date may be postponed to a new date. Written notice must be given at least 6 months prior to original date. New date must be within 12 months of original wedding date and is subject to Andrew Szopory Photography’s availability. A \$200 fee is payable to change the date.
